Such notice shall require the electors to cast ballots which shall contain the words: "Irrigation district--Yes," or "Irrigation district--No," or words equivalent thereto, and also the names of persons to be voted for to fill the various elective offices hereinafter prescribed. N o person shall be entitled to a vote at any election held under the provisions of this act unless he or she is a bona. fide landowner in the district and of the age of twenty-one years or...
